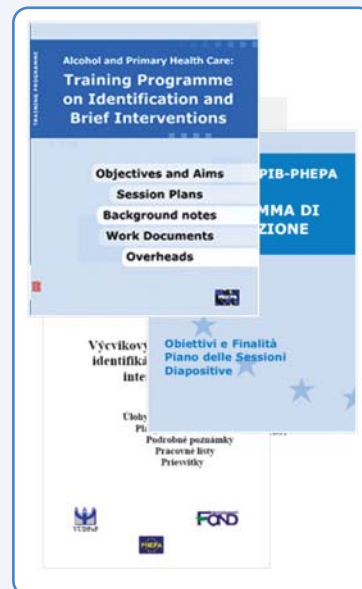

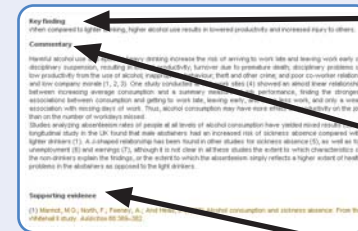

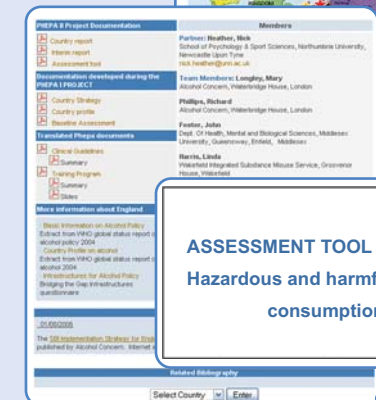

Introduction

- Alcohol is a main public health problem that contributes enormously to the workload of Primary Health Care professionals.
- European Primary Health Care professionals need training and clear guidelines on how to intervene in alcohol related problems, ranging from risky drinking to severe dependence.

Phepa contribution

- The Phepa project, cofinanced by European Commission, has helped to create an important network of European scientists devoted to the SBI field
- The benefits of this network are both scientific and strategic, since its existence acts by itself as a 'lobbying' group.
- Phepa has contributed to the homogenisation of the intervention criteria at European Level by producing and rolling out European clinical guidelines on alcohol, a training programme for Primary Health Care, a web site on good clinical practice and a series of country based strategies.
